#### **COMMITTEEMAN'S CORNER**

Welcome to October and this month's updates. As a lot of you know this past month the National Organization has been dealing with the fallout of the Colorado Prison Post, this has been on the main burner for all Department Commander as well as Council Members taking calls concerning this Post and its members. Below is the official communication and letter from National concerning this issue.

#### Commanders and Comrades.

National Commander in Chief Al Lipphardt has issued a ruling that VFW eligible veterans currently incarcerated for Felony offenses have failed to meet the high standards of VFW membership as they have not completed the terms of their conviction for the crimes they were found guilty of.

As such the members of Post 12226 that are inmates with felony convictions will have their membership in the VFW revoked and will not be eligible to transfer or appeal this decision. Once the terms of their conviction has been completed and they are released from prison they would be eligible at that time and subject to approval per our Bylaws.

The Chief has also been informed that several members of the Post — who are not inmates — will transfer to Member At Large which will cause Post 12226 to fall below the minimum members required to maintain a VFW Post Charter and therefore, the Chief is preparing to revoke the Charter of Post 12226 the first week of October.

The Department of Colorado in no way was using this Post as a way to boost or increase membership numbers as has been alleged. Quite simply they were trying to assist VFW eligible incarcerated veterans by giving them a unigue program inside the prison walls in an effort to help the veterans confined there.

Furthermore the Chief has directed the National Bylaws review committee to strengthen Section 100, Membership Eligibility of the National Bylaws to clearly define his ruling for adoption or rejection by the Delegates at the next National Convention."

During the last Council of Administration Meeting held in September it was voted on to resend the authorization for the California MC to use the VFW Logo and name as they would not abide by the rules set forth for our VFW Riders. This has been a long running issue that has finally been set to rest. A certified letter from the Quartermaster General was sent to those in charge informing them of this vote. The weekly updates that I was sending to the District Commanders are now only generated from National on a monthly basis unless there is something that really needs to be put out, so check with your District Commanders to make sure you have the latest update.

This has been a busy month for the Council and I am grateful that the members of this Department have elected me to represent you on the Council.

Until next month keep doing those buddy checks and renewing, recruiting and reinstating members into our organization.

#### Veterans of Foreign Wars Department of Louisiana Legislative Report September 2024

These are the key Topics from this month. Please read through these and let me know your thoughts on how we can continue to show Louisiana, that our Elected Officials are committed to our Veterans.

#### September 2nd:

Applications Now Being Accepted for 2024-2025 VFW-SVA Legislative Fellowship: The application process for the 2024-2025 class of VFW-SVA legislative fellows is now open. VFW members who attend an accredited institute of higher learning will be chosen for the semester-long program that focuses on real policy issues faced by veterans, service members, and their families. The capstone of the program is participation in the 2025 VFW Washington Conference in Washington, D.C. Alumni of the program have become more active at all levels of the VFW and SVA, and have been instrumental in changing laws to improve care and benefits for veterans. Learn more and apply for the fellowship. Access Issues with 988 Veterans Crisis Line: Veterans calling the Veterans Crisis Line (VCL) are experiencing issues with the "988 then press 1" audio prompt. VA is working with VCL to reroute calls and ensure dropped calls receive a callback. If you or someone you know have experienced these difficulties, please use the VCL Chat option or connect through text messaging by using number 838255 as alternate ways to receive support. These options are not impacted by the current phone line issues. Additionally, veterans can call 1.800.MYVA411 and then press 7 for further crisis assistance. The VFW will continue to monitor the situation.

Pre-Need Assistance for Final Arrangements: Proactive planning can assist veterans and reassure their survivors regarding final arrangements. Pre-need determination of eligibility for burial benefits enables family members to honor final wishes and settle personal affairs. Veterans can apply to find out if they are eligible for interment in a VA national cemetery. Though participation does not guarantee burial in a specific cemetery, it does inform VA of preferences and helps to fulfill requests. Read more about the program and learn how to report a veteran's death to VA. Locate an accredited representative for assistance with survivor benefits claims.

#### September 9th:

Calling All Vietnam Veterans: The Government Accountability Office (GAO) is asking VFW members to participate in a short interview about open-air burning (e.g., burn barrels, burn-out latrines, and burn pits) if you are a veteran who was deployed on land or at sea to the Vietnam theater (Vietnam, Cambodia, or Laos) between 1955 and 1975. GAO's report will be publicly available on its website and sent to Congress, VA, and DOD. The plan is to complete the phone interviews by the end of Monday, Sept. 30. To participate, please email VietnamBurnPits@gao.gov or call 202.512.5624.

VFW Remembers 9/11: This week is the 23rd anniversary of the terrorist attacks that changed America forever. The memories of that day are still vivid, but the heroism that emerged from the rubble of the World Trade Center, the Pentagon, and in the air above a rural Pennsylvania field should inspire us for generations to come. As we remember 9/11 and the nearly 3,000 innocent lives lost that terrible day, the VFW hopes all Americans pause to reflect and also keep in mind those who continue to sacrifice in the defense of freedom.

. POW/MIA Recognition Day 2024: Today, nearly 82,000 service members and civilians remain unaccounted for from conflicts dating back to World War II. The role of the Defense POW/MIA Accounting Agency (DPAA) is to provide the fullest possible accounting of missing personnel to their families and the nation. Each year, DPAA creates a poster in advance of POW/MIA Recognition Day, which will be commemorated this year on Sept. 20. This year's poster bears the words "Honoring their sacrifice. Earnestly searching for those still missing."

#### September 16th:

VA Budget Shortfall Action Alert: Recently, VA announced a budget shortfall that may delay the timely delivery of benefits to people nationwide. Veterans, family members, and caregivers have earned VA benefits through service, and we are frustrated to hear certain ones may not be adequately funded through the end of the fiscal year. This is not a problem caused by Congress, but our elected officials in Washington, D.C., have the responsibility to ensure these benefits are paid on time to those who have earned them. Each year VA has been provided with the resources it requested for veterans' care and benefits, and our legislators must ensure that happens this time as well. Congress must pass a supplemental funding bill by Sept. 20 to make sure veterans, survivors, and caregivers receive next months' benefit payments without interruption. Congress must also hold VA accountable to prevent issues like this from happening in the future. However, this accountability can happen AFTER Congress provides supplemental funding, so veterans, survivors, and caregivers do not go without or face financial difficulties due to inadequate government funding.

Congress Congratulates VFW on 125th Anniversary: In a show of support for the 125th anniversary of the VFW, fellow VFW members Reps. Derrick Van Orden and Chris Deluzio, and Marine veteran and House Committee on Veterans' Affairs Chairman Mike Bost have introduced a concurrent resolution recognizing Sept. 29, 2024, as "Veterans of Foreign Wars of the United States Day." For more than a century, the VFW has advocated on behalf of veterans to ensure they have timely access to their earned benefits, and has served veteran communities here and around the world. Read the resolution and learn more about the legacy of the VFW.

VFW Fall Legislative Conference: The VFW National Legislative Committee members met with senators, representatives, and staffers in Washington, D.C., to discuss the VFW's legislative priorities. Specific focus was on providing health care and benefits for veterans, caregivers, and survivors; ensuring the continuous review of new presumptive conditions related to toxic exposures; exploring alternative treatments for post-traumatic stress disorder and other mental health conditions; and continuing to promote legislation to penalize predatory claim companies known as Claim Sharks. The VFW will continue to advocate for these issues to assist service members, veterans, and their families.

#### September 23rd:

Congress Approves Emergency VA Funding: The Senate passed the House-introduced emergency appropriations bill to cover the VA's \$3 billion-dollar budgetary shortfall. If a spending bill had not passed by the end of the week, the results would have been financially devastating to millions of veterans. It's worth noting that this bill would not have passed with bipartisan support if not for veteran advocates within Congress and the veteran community. The nearly 7 million veterans who rely on VA benefits, to include disability compensation and even the GI Bill, can now have peace of mind that benefits will be delivered on time, October 1.

VFW Testifies at House Subcommittee Oversight Hearing: VFW Washington Office Executive Director Ryan Gallucci testified at a House Subcommittee on Disability Assistance and Memorial Affairs oversight hearing on how the VA can improve the quality of contracted disability compensation examinations. In this fiscal year alone, VA reported that more than 217,000 exams were returned to VA as "no-shows." Gallucci commented, "At a time when VA is processing more benefits than ever before, we have the responsibility to make this process as user-friendly as possible." VFW Addresses Food Insecurity: VFW Assistant Director of Field Operations Cindy Noel traveled to Capitol Hill to meet with the For Country Caucus (FCC) for a discussion on how food insecurity impacts service members and veterans. According to the FCC, their focus is to provide its military veteran members the opportunity to work together across party lines to pass comprehensive legislation regarding national security, veterans affairs, and national service. Noel's remarks emphasized the challenges involved during the periods of active duty, transition, and after separation from the Armed Forces.

Massage Therapy Fraud Warning: The VA Office of Inspector General (OIG) is asking veterans to assist in stopping billing fraud for massage therapy. Because VA provides coverage that many other insurers do not, massage therapy is an area that bad actors are exploiting. According to OIG, the most common type of fraud entails billing for services not rendered or upcharging for therapy received. Learn how you can help.

#### September 30th:

House Committee Oversight Hearing: The House Committee on Veterans' Affairs held an oversight hearing titled Everyday Heroes: Supporting the Veteran Caregiver Community. In a statement submitted for the record, VFW National Legislative Associate Director Meggan Coleman commented on the selflessness of family members and friends who become caregivers to give their veterans the best quality of life. Ensuring caregivers have essential training, resources, and mental health coverage would reduce the barriers of burnout and economic hardship. The VFW strongly urges Congress to pass H.R. 8371, Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act, which would enhance and reform the delivery of services at VA by prioritizing veterans and their families, caregivers, and survivors. Read the testimony.

VFW Participates in Alternative Therapies Roundtable: VFW National Legislative Director Pat Murray took part in a roundtable regarding alternative therapies for various mental health conditions. The event was led by Reps. Derrick Van Orden and Marcus Luttrell, both of whom are VFW members. The discussion centered around different treatments such as cannabinoids, psychedelics, hyperbaric oxygen, and faith-based options. The VFW supports research for alternative therapies for post-traumatic stress disorder (PTSD) and is grateful these members of Congress and fellow veterans are making it a priority. Watch the roundtable.

VFW Supports TAPS Gold Star Families Advocacy Week: The VFW Washington Office hosted the 2nd Annual Tragedy Assistance Program for Survivors (TAPS) Gold Star Families Advocacy Week Event. Together with partner veteran organizations, volunteers advocated for legislation to improve benefits and services for survivors. VFW National Legislative Deputy Director Kristina Keenan participated in meetings with members of Congress to show the VFW's strong support for S.414 / H.R.1083, Caring for Survivors Act of 2023, to extend CHAMPVA and TRICARE coverage for surviving children to age 26, and update the definition of surviving spouse. Read more.

Veterans Service Organizations Collaborate on Toxic Exposure Study: VFW Washington Office staff attended a joint Disabled American Veterans and Military Officers Association of America briefing about timeliness in identifying, cataloguing, and establishing presumptive conditions for adverse health cases attributed to environmental toxins. Their Ending the Wait for Toxic-Exposed Veterans report describes the years-long process to recognize toxic exposure related to an event. According to their research, veterans generally wait 34.1 years for the full suite of earned health care services and benefits to treat the effects of toxic exposures. The report also offers suggestions to overhaul the process and ensure prompt access to this lifesaving care. Read the report, learn more about toxic exposure benefits, or find an accredited representative to assist in filing a claim.

VA Expands Tele-Emergency Care Options: VA has announced tele-emergency care (tele-EC) is now available nationwide, which is a service that aims to improve access to virtual emergency care options. Veterans enrolled in VA health care can now contact tele-EC via VA Health Connect by phone or the VA Health Chat app. They can also find contact information for VA locations in their local areas. Learn more about eligibility or how to apply for health care benefits.


