BEWARE OF CLAIM SHARKS!

Recently, a VFW Post was approached by a company offering to conduct a VA Claims Clinic at their location, including a proposal to pay for the hall rental. At first glance, this seemed like a beneficial opportunity for both veterans seeking assistance with their claims and the Post itself, which would gain rental income.

However, it was later discovered that this event was sponsored and coordinated by a known "Claim Shark." It is imperative that any company claiming to assist with VA claims be thoroughly vetted through your Department Service Officer (DSO) or their staff, or National Veterans Service (NVS). We cannot permit these companies to exploit our space to take advantage of veterans and their hard-earned benefits.

The VFW has taken significant measures to combat these predatory claims companies and their illegal practices. Many of you have joined in this fight at the state and federal level, and I thank you for your vigilance and your efforts.

We also understand that some within our ranks may disagree with this stance. Nonetheless, it is crucial to understand and adhere to the organization's strategies and positions: These are illegal practices that prey on veterans and their families and must be stopped.

Allowing such companies to operate on our premises directly contradicts the resolutions of our organization, as approved through the National Convention by an overwhelming majority of convention delegates just two weeks ago. If you or your staff are approached with such an offer, please contact your Department Service Officer to verify that you are not inadvertently "feeding the sharks."

We all understand that these companies are trying to be clever in presenting their illicit services as a flashy and viable path for veterans. Make no mistake, they only see veterans as dollar signs, and it is our responsibility to stop them. We cannot under any circumstance let these companies normalize or legalize the financial exploitation of veterans, caregivers, and survivors.

Your Department Service Officer and their staff have access to resources to help veterans affected by these companies and their illegal practices. Please ensure any requests to assist with VA benefits at your post or events are properly vetted through your DSO or NVS staff.

General Orders 2024-2025 Series No. 1

Attention Post Commanders: All general orders should be read at your meetings and filed in post files for future references. General Orders will also be on the Department website at www.vfwdeptla.org.

- 1. Having been elected Commander, VFW Department of Louisiana and having been installed in office in accordance with the Bylaws of the Veterans of Foreign Wars of the United States, I hereby assume command.
- 2. The following officers have been duly elected and installed by the 93rd Department Convention and will be accorded the recognition due them:

- **5.** <u>Proof of Eligibility</u>: Failure or refusal to submit proof of eligibility within 60 days of election or appointment shall result in the <u>office being declared vacant</u>. <u>Post officers are reminded to check files on proof</u>. <u>Proof of Eligibility will be checked by the end of Nov!</u>
- **6.** <u>Taxes:</u> An annual income tax return (Form 990 or 990-T) is required for each Post exempt from tax under Section 501 (c) of the code. If \$25,000 or less the Internal Revenue Service requests only the heading on page 1 be completed, being sure to check Box B, and send it to the IRS center in your area. This <u>must be filed on or before the 15^{th} day of the fifth month after the end of the Dept's Fiscal Yr.</u>
- **7.** <u>Articles Of Incorporation:</u> Posts must have Articles on file with the Secretary of State are reminded that they have must file the annual report each year. If a Post **fails** to file, the Annual Report and pay the \$10.00 fee -- the Post Article of Incorporation become INACTIVE and Post must **reactivate** the Article of Incorporation at a fee of around \$75.00.

- **8.** <u>Resolutions:</u> Are proposed and approved by a <u>Post</u> then by <u>District</u> before being forwarded to the <u>Department</u> thirty days prior to State Convention for delegate action.
- **9.** <u>All American Dashboard Now Known As The "Program Dashboard":</u> Post Adjutants should have access to the National Program Dashboard by logging in at www.vfw.org. Post Adjutants should receive all Program Information from Chairman within the Post and enter the information in the National Program Dashboard. Once the Post Adjutant enters this information, it must be approved by the District Adjutant.




A message from our State Sr. Vice Commander....

A message from our State Quartermaster....

Comrades,

It's time to ensure your Post's 990 Taxes are being prepared for filing in the 2023-2024 fiscal year. The filing deadline is November 15, 2024. If your Post's annual gross receipts normally exceed \$50,000, you must file Form 990 or 990-EZ. If your annual gross receipts are \$50,000 or less, you are required to submit Form 990-N, also known as the e-Postcard. Maintaining your Post's active tax-exempt status is crucial for establishing credibility and commitment within our organization.

Additionally, Post should verify that the annual filing with the Secretary of State has been completed, and update the listed officers and registered agent if needed. It's important not to let your Articles of Incorporation filed with the Secretary of State become inactive.

We will host a Post Quartermaster Zoom Conference on Saturday, September 7th at 4:00 p.m. All Post Quartermasters will receive an amail inviting them to attend. It will be an informal meeting, so if you

Sec. 103 - Election.

Applications. After the applicant has filled out the application card, it should be provided to the Post Adjutant or Quartermaster, together with the dues (and admission fee, if applicable). A receipt shall be given to the applicant.

An applicant may be recommended after eligibility has been fully determined by the Post Reviewing Committee. With respect to a Department Member-at-Large, the National Organization and/or the Department Headquarters will be responsible for eligibility determination. The original application of every member will be retained on file with the Adjutant.

Balloting on Applications.

Before voting on the application during a Post meeting, the Commander shall allow the members present an opportunity to state their objections, if any, to the admission of the applicant. Unless one member present shall request a written ballot, a vote shall be taken and a majority of the votes cast shall decide acceptance or rejection of the application.

Until next month keep doing those buddy checks and renewing, recruiting and reinstating members into our organization. Check with your District Commanders for the weekly updates that I send them concerning operations at the KC and DC offices.

Veterans of Foreign Wars Department of Louisiana Legislative Report August 2024

These are the key Topics from this month. Please read through these and let me know your thoughts on how we can continue to show Louisiana, that our Elected Officials are committed to our Veterans.

August 5th:

Highly Decorated Vietnam Veteran Elected to Lead VFW: Alfred J. "Al" Lipphardt was elected as the new national commander of the VFW at the 125th VFW National Convention held this year in Louisville, Kentucky. "I am deeply humbled to stand before you today having been elected and installed to the highest office of the Veterans of Foreign Wars of the United States, commander-in-chief," said Lipphardt. He earned his VFW eligibility by serving in Vietnam from 1967 to 1968, and from 1970 to 1971. In recognition of his heroic service in combat, he received the Combat Infantryman's Badge, Bronze Star with "V" device, Bronze Star Medal for Meritorious Service, Purple Heart Medal, Vietnam Campaign Medal with Silver Star and two Bronze Stars, among many others. He joined the VFW in 2002 at Post 12002 in North Fulton, Georgia. Read more.

Housing Program Expands to More Veterans: The U.S. Department of Housing and Urban Development (HUD) has expanded the HUD-Department of Veteran Affairs (VA) Supportive Housing (HUD-VASH) program. When determining eligibility for supportive housing vouchers, VA disability benefits will no longer be considered income. This will enable more veterans to meet the income threshold required for the program. The VFW has been advocating for this change for years and commends HUD for making this adjustment to address veterans' housing needs. Read more.

Expanded Benefits Access for Karshi-Khanabad Veterans: VA has announced that veterans who served after Sept. 11, 2001, at Karshi-Khanabad (K2) base in Uzbekistan should soon receive expanded access to benefits. Taking steps to acknowledge the presence of various contaminants at K2 will enable VA to ensure appropriate health care and compensation for these veterans and their survivors. In comments regarding this expansion, VA Under Secretary for Benefits Joshua Jacobs explained, "At VA, our goal is to provide every veteran who served at K2 with the care and benefits that they deserve for their service to our nation — and that's what this effort is all about." What we think a "Claim Shark" is:

- A Claim Shark is an individual or company that charges hefty fees to "assist" or "consult" veterans with filing their VA benefit claims – this practice is illegal!
- Claim Sharks are not VA accredited, meaning they aren't required to adhere to the well-established professional and ethical standards of VA accreditation, so their advice can often be misleading or even fraudulent.
- Like a "Loan Shark," once you're in, you can't get out, and may be subject to new and hidden fees whenever you get a new rating, no matter who does the work.

Some of their predatory practices are:

- Promising or guaranteeing an increased disability rating or percentage increase.
- Advertising expedited VA claims decisions.
- Requesting login credentials to access a veteran's personal information through secure VA websites like eBenefits or VA.gov.
- Using confusing tactics or ambiguous language to mislead claimants or coerce them into signing a contract.
- Telling veterans to forego VA exams and offering health consultations within their own network of doctors.
