Grant eligibility is exclusive to VFW entities such as Posts, Districts, and Auxiliaries. Nonprofits outside of the VFW cannot apply. All grants are reimbursement-based, meaning applicants must complete their projects and then apply with proof of expenses.

PLEASE NOTE: ALL GRANT APPLICATIONS FROM VFW POSTS MUST BE COMPLETED VIA THE DASHBOARD at VFW.ORG. CONVERSELY, VFW AUXILIARIES WILL APPLY FOR GRANTS THROUGH PDF APPLICATIONS WHICH AT THE MOMENT ARE UNAVAILABLE (Expected availability is likely after September 19).

We highly encourage applicants to contact the VFW Foundation before starting a project to ensure it qualifies.

# A message from our State Adjutant....

**Are you too busy and seem that you can not get anything completed?**

1. Prioritize with a daily "Top 3"
  - Pick the three most important tasks for the day — not the longest, but the ones that matter most.
  - This keeps you focused and prevents busywork from taking over.
2. Time-block your day
  - Assign specific windows for tasks: email, planning, deep work, errands.
  - Even loose time-blocking reduces decision fatigue and keeps you from drifting.
3. Remove one distraction at a time
  - Instead of trying to "be more disciplined," eliminate a single distraction: silence notifications, close extra tabs, or put your phone in another room.
  - Small changes compound quickly.
4. Use a simple capture system
  - Keep one place — a notebook, app, or planner — where every idea, task, or reminder goes.
  - This frees your mind from holding everything and reduces forgotten commitments.
5. Review and reset weekly
  - Spend 10–15 minutes each week looking at what worked, what didn't, and what needs adjusting.
  - This keeps your system flexible instead of rigid.

## ALL STATE & ALL AMERICAN DOES MY POST QUALIFY?

To be eligible for All State and All American we always hear that my post must be in good standing. What does this really mean?

To maintain good standing as a VFW Post, it must adhere to the following requirements:

- Post must have a Charter (Sec 201 Bylaws)
- Formation. A Post may be formed by completing a charter application consisting of twenty-five (25) eligible veterans, of which at least ten (10) must be new members, submitted through proper channels to the Commander-in-Chief.
- Remedy:
- Ensure you have a copy of the Post Charter. If you do not request a copy from National for \$25
- Post shall adopt Bylaws (Sec 202 Manual of Procedure)
- Copies of Bylaws, including amendments adopted by a Post shall, within thirty (30) days, be forwarded to the Department Commander for review and forwarding to the Commander in-Chief. Bylaws or amendments adopted by a Post shall become effective upon review by the Commander-in-Chief, provided such Bylaws do not conflict with the Bylaws, Manual of Procedure, Ritual or laws and usages of the Veterans of Foreign Wars of the United States.
- Remedy:

- From drop down menu click on forms
- Click on PostBylawsTemplate 2024.pdf
- Fill in blank areas
- Follow Sec 202 ByLaws to establish a vote by the Post
- Copies of Bylaws, including amendments adopted by a Post shall, within thirty (30) days, be forwarded to the Department Commander for review and forwarding to the Commander in-Chief. Bylaws or amendments adopted by a Post shall become effective upon review by the Commander-in-Chief, provided such Bylaws do not conflict with the Bylaws, Manual of Procedure, Ritual or laws and usages of the Veterans of Foreign Wars of the United States.
- Regular Meetings. (Sec 203 Bylaws)
- Post shall hold at least one regular meeting each month.

- The Post Bylaws may specify the minimum number of members required to constitute a quorum for the transaction of business at a regular or special meeting, provided that in no case shall the quorum be less than five (5) members.
- **Remedy:**
- **Hold your meetings as outlined in Commanders Book**
- **IF you do not have a quorum, do not give up reach out to members via the phone. They can attend telephonically.**
- Arrearages, Deficiencies and Omissions. (Sec 213 Bylaws)
- Any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money,
- Failing to have the office of Quartermaster properly bonded in accordance with Section 703,
- Bonds (Sec 703 Bylaws) Each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which, so far as can be anticipated, they may be accountable. The bond premium shall be paid from the funds of the Veterans of Foreign Wars of the United States, Department, District, County Council or Post to which each officer is accountable. The bonds of such accountable officers, in amount and as to surety, shall be approved by their respective units and held by their respective Commanders. The Commander of each unit shall be responsible for the proper and adequate bonding of all accountable officers in their unit.

- failing to ensure that the Post is properly insured in accordance with (Sec 709 By laws)
- Any Post, County Council, District or Department owning and/or operating, directly or by reason of a holding company or other entity



substantially controlled by the Post, County Council, District or Department or its members, a canteen, clubroom or other facility available to members or guests must maintain general liability insurance, including, if necessary or appropriate, liquor liability insurance. Such insurance must be of a type and amount sufficient to protect the Post, County Council, District or Department and must name, as additional insureds, the Veterans of Foreign Wars of the United States and the Department in which such Post, County Council, District or Department is located.

- **Remedy:**
- **There are many companies that will provide insurance to post. Shop around, talk with other posts, know your Posts needs.**
- failing to submit properly completed quarterly Post Trustees Report of Audit (Sec 218.11 Manual of Procedures)
- Trustees shall not be eligible to serve as an elected officer, Adjutant or on a committee whose books, records and accounts are audited by the Trustees. Among the duties of Post trustees, they shall:
  - a. At least monthly, review the Monthly Report of Receipts and Expenditures of the Post Quartermaster.
  - b. Within thirty (30) days from the end of each quarter, properly audit the books and Record of the Post Quartermaster, Post Adjutant, and any activity, club room, holding company or unit sponsored, conducted or operated by, for or on behalf of the Post and submit a Post Trustee's Report of Audit to the Department Quartermaster for referral to the Department Inspector.
  - c. The Report shall be in accordance with and upon such form as may be prescribed by the Adjutant General. The audit shall be signed by the Post Commander and Trustees, who shall, by their signatures, certify to the accuracy of the information contained therein.
- **Remedy:**

  - Fill in blank areas based on provided documentation.
  - Print form out for Review and THREE SIGNATURES
  - Send completed form (Hardcopy, Picture or Scanned) to Department within 30 days of the quarter closing.
- Post Election Report for the Ensuing Year, (Sec 218a,1,i Manual of Procedures)
    - i. Assure that all reports are correctly prepared and promptly forwarded, that all Business of the Post is handled with dispatch and that all necessary licenses and permits are obtained for proper operation. Ensure that a properly completed Report of Election of Officers for the Ensuing Year is submitted to Department and National Headquarters by June 1.
    - Remedy:
    - After Post and District elections QM should complete the election report completely. You will find the Election Report on the VFW home page. VFW.ORG
    - VERIFY all information is correct. Verify spelling of names, phone numbers, email address and physical address.
    - If you have a change of officers you can resubmit the election report to insure that HQ has the current information.
    - or other obligations, shall be deprived of all representation in County Council and District meetings, County Council, District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.
  - Posts will submit other obligations, specifically the IRS Form 990 annually. (Sec 218.a.5. j Manual of Procedures)
    - j. File appropriate forms as required by Federal, State and Local Statutes or regulations.
  - Important Reminders:
    - All Post should be filing on a Fiscal Year (July 1 to June 30th)

- **Due Date:** The 990 filing (any version) is due on the **15th day of the 5th month after the end of the fiscal year, so for VFW Post the due date is November 15th.**
- **Failure to file for 3 consecutive years results in automatic revocation of tax-exempt status**

To keep your Post non-profit status a 990 must be filed before **November 15** of each year.

### **Which 990 Form should a Post file?**

The 990 form a Post must file depends on its financial activity, as indicated below:

#### **Form Type Eligibility Details**

**990-N** Gross receipts normally \$50,000 or less per year Filed electronically only. Very short form.

**990-EZ** Gross receipts more than \$50,000 but less than shorter version of full 990 \$200,000, and assets under \$500,000

**990** Gross receipts \$200,000 or more, or assets Full Form (Detailed) \$500,000 or more

**990-T** If the Post has unrelated business income (UBI) In addition to 990 filing over \$1000

- Post Annual Inspection completed (Sec 418,a,11 Manual of Procedures)
- The District Inspector shall ensure that each Post in the District is inspected in accordance with the Department Bylaws or as directed by the Department Commander. The requirements of such inspection are:

1. That all books and records are inspected in accordance with a properly executed Inspection Form.

2. The Inspector shall provide a copy of each inspection to the Post Commander, District and Department and set forth therein any constructive criticism and recommendations. The Inspector shall perform such other duties as may be incident to the office or may be from time to time required by the laws and usages of the organization or on lawful orders of proper authority.

January 12 th :

VFW Commander Congratulates Operation Absolute Resolve Troops: VFW National Commander Carol Whitmore released a statement commending the U.S. service members involved in Operation Absolute Resolve for their swift and precise mission achievement. "In complex and demanding conditions, these men and women upheld the highest traditions of the U.S. Armed Forces," said Whitmore. "Their discipline and commitment to mission execution reflected the values that generations of veterans have sworn to defend." Read the statement.

VFW 2026 Priority Goals: The 119th Congress is now in its second session, and there is still much work to be done. The VFW 2026 Priority Goals include many issues concerning benefits and services for veterans, service members and their families such as the Major Richard Star Act, VA community care reform, ending mental health overprescription harm and exploring alternative treatments for invisible wounds. The VFW will continue to advocate diligently to ensure members of Congress and the Departments of Veterans Affairs, Defense and Labor provide the resources and care our nation's veterans have earned and deserve.

VFW-Supported Tuition Fairness Bill Signed into Law: H.R.983, Montgomery GI Bill Selected Reserves Tuition Fairness Act of 2025, is now Public Law 119-55. Introduced by Rep. Van Orden (WI-3), this bill was approved by the House without objection and passed the Senate by unanimous consent. It requires VA to disapprove courses provided by educational institutions that charge higher than in-state tuition for individuals utilizing the Montgomery GI Bill-Selected Reserve benefits while living in the state where the education is located, regardless of the individual's state of residence. The VFW applauds the passage of this legislation.

VA Warns About New Benefits Scam Targeting Veterans: The VA announced that scammers are impersonating its representatives to deceive veterans, surviving spouses and family members into believing their VA benefits have been overpaid and must repay immediately. These fraudulent contacts may arrive via letters, emails, text messages or phone calls and include fake VA logos, letterheads and spoofed phone numbers to appear legitimate. Veterans can protect themselves by only using official VA channels to resolve any real overpayments, never sharing sensitive information like VA login information, and being cautious of urgent demands for quick payment. Veterans who believe they have been targeted should contact the VA at 1-800-827-1000 and can file a complaint with the Federal Trade Commission or at [VSAFE.gov](https://vsafe.gov). Read more.

January 19<sup>th</sup> :

VFW Attends SVA NatCon 2026: VFW members were recognized for their outstanding commitment to the student veteran community during the Student Veterans of America (SVA) 18th Annual National Conference (NatCon), held this year in Colorado Springs, Colorado. Past VFW National Commander Brian Duffy addressed the conference's general session noting, "Education prepares you for tomorrow. Advocacy protects it." He concluded by stating, "Together, the SVA and VFW are still serving. We are still leading. And we can never stop thinking about tomorrow, because the next generation of warriors depends on us." VFW National Veterans Service Assistant Director of Field Operations Cindy Noel and VFW National Pre-Discharge Claims Representative Rick Boring assisted student veterans at a claims clinic on site. VFW National Legislative Service Associate Director Gabby Kubinyi participated in the event's "Meet Your Veteran and Military Service Organizations" panel discussion.

VFW Testimony for Subcommittee Oversight Hearing: VFW National Veterans Service Director Michael Figlioli submitted a statement for the record for a House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs hearing on efforts to modernize disability benefits. The hearing did not include any witnesses from organizations with VA accredited representatives, allowing misconceptions of the rating schedule to go unchallenged before the committee. In his statement, Figlioli commented on VA's ongoing modernization of the Veterans Affairs Schedule for Rating Disabilities (VASRD), which is a critical component of VA's disability compensation system. His statement describes VA's plan, its progress to date, and obstacles impeding its completion. Since establishing this schedule in April 1945, VA has continually updated the VASRD to ensure fair and accurate compensation based on current medical science and labor market conditions. Rather than acting as a safety net, the current structure offers a more objective evaluation based on the veteran's "average impairment of earnings capacity," compared with that of similarly situated civilian workers. VFW-Supported Tuition Fairness Bill Signed into Law: H.R.983, Montgomery GI Bill Selected Reserves Tuition Fairness Act of 2025, is now Public Law 119-55. Introduced by Rep. Van Orden (WI-3), this bill was approved by the House without objection and passed the Senate by unanimous consent. It requires VA to disapprove courses provided by educational institutions that charge higher than in-state tuition for individuals utilizing the Montgomery GI Bill-Selected Reserve benefits while living in the

state where the education is located, regardless of the individual's state of residence. The VFW applauds the passage of this legislation.

**Women Veteran Committee Hill Day:** The VFW and 12 other veteran organizations spent a day of advocacy on Capitol Hill aimed at garnering support and co-sponsorship for five specific pieces of legislation. These proposals would evaluate existing research on menopause, focusing on care quality and access. They would also improve outreach for women veterans, integrate gender-specific risk factors into mental health services, mandate annual sensitivity training for all VA employees and contractors handling claims related to military sexual trauma (MST), and extend MST-related mental health counseling to former National Guard and Reserve members. VFW National Legislative Service Associate Director Meggan Coleman commented, "These pieces of legislation are important because they offer an opportunity for equal benefits for all who have selflessly sacrificed to defend our country."

**VA Class on Airborne Hazards & Burn Pit Exposure:** On January 22, 2026, the Department of Veterans Affairs will be offering a session for veterans titled "Airborne Hazards and Burn Pits: What You Need to Know", [register here](#). VA offers education classes for veterans via telehealth to provide veterans with the most current information and education on deployment related health concerns. VA offers a variety of classes throughout the year to keep veterans informed about research, access to integrative health services, and more to optimize their wellbeing. [Learn more](#).

**VFW Podcast discusses Major Richard Star Act, Updates for New Year:** On the latest episode of #StillServing: The VFW Podcast, guests VFW Assistant Adjutants General Brian Walker and Ryan Gallucci and VFW National Legislative Service Associate Director Joy Craig team up with host Rob Couture for the first show of 2026. Join them as go in depth on the Major Richard Star Act, the latest National Defense Authorization Act, potential threats to VA disability compensation, VFW resolutions, the U.S. military operation in Venezuela and more. January 26 th :

**House Committee Roundtable on Scams Targeting Veterans:** VFW National Veterans Service Director Michael Figlioli participated in a House Committee on Veterans' Affairs roundtable on preventing scams against service members, veterans and their families. The discussion highlighted how fraudsters deliberately target veterans of all ages, often exploiting the perceived reliability of VA disability compensation and the trust inherent in military culture. Panelists shared firsthand accounts of fraudulent schemes and emphasized the need for a coordinated prevention approach to include strengthening education and outreach, rigorously enforcing existing laws, and advancing legislation to hold bad actors accountable. Watch the roundtable, which starts at the 15:38 mark.

**House Subcommittee Pending Legislation Hearing:** VFW National Legislative Service Associate Director Joe Grassi provided a statement for the record on pending legislation to the House Veterans' Affairs Subcommittee on Economic Opportunity. The VFW expressed support for several proposals that would strengthen education, military-to-civilian transition and employment outcomes for veterans.

Regarding H.R. 982, Warriors to Workforce Act, that would increase the housing allowance for apprenticeships, Grassi wrote, "In terms of this housing allowance, an increase from 80 percent to 100 percent would realistically help veterans complete these important education programs that provide direct

job training while ensuring their basic housing needs are covered.” Read the testimony or watch the hearing, which begins at the 26:33 mark.

**VFW Launches New Targeted Action Alert on Major Richard Star Act:** The VFW has launched a new action alert urging Congress to advance the Major Richard Star Act. This legislation would correct a long-standing injustice affecting combat-disabled veterans whose earned retirement pay is currently offset by VA disability compensation. Unlike traditional alerts, this one uses a dynamic, targeted approach, delivering a tailored message to each member of Congress based on their role and position in the legislative process. This “living” alert will evolve as the bill moves forward, ensuring lawmakers continue to hear directly from those who are affected. Veterans and supporters are encouraged to take action and make their voices heard at this critical moment.

**VFW Meets With Troops on NATO’s Eastern Flank:** VFW National Commander Carol Whitmore and Washington Office Executive Director Ryan Gallucci recently traveled to Poland to meet with U.S. service members at Camp Kościuszko, home of U.S. Army V Corps Headquarters (Forward) and U.S. Army Garrison Poland, which oversees 12 installations and supports operations along NATO’s eastern flank. Discussions focused on VFW advocacy priorities, earned benefits, transition assistance and the unique challenges of serving overseas. The visit underscored the importance of honoring commitments to those stationed on NATO’s front line and reaffirmed the VFW’s dedication to supporting troops wherever they serve. A previous visit led the VFW to champion proper recognition for eastern flank service—a resolution the VFW continues to renew and advocate for today.

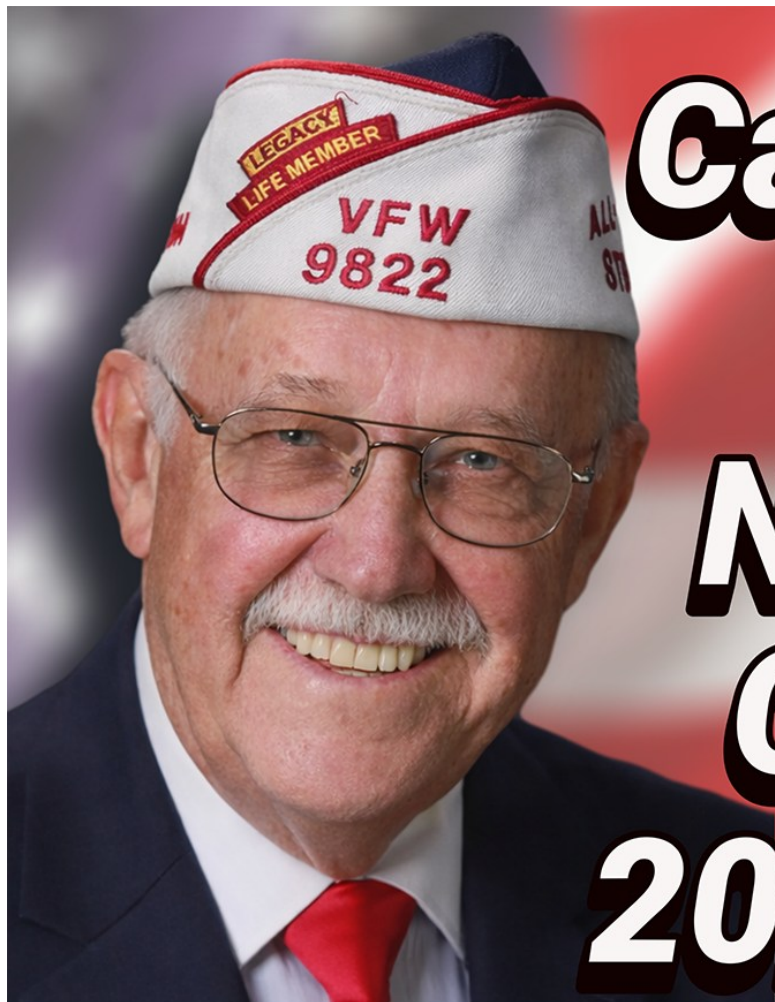
